The Clerk reported that draft proposals had been received from C.A.L.C. as to how Councils' could implement these new regulations. These had been circulated by email to Councillors. It was suggested that this matter be referred to the Communications and Engagement Committee for further consideration. The Clerk also pointed out that the Council's Standing Orders 2011 – General Meetings 1 (m) currently prohibits recording of meetings of the Council. To take account of the new 2014 Regulations it was proposed by the Mayor and seconded by Councillor Brooks and the Council <u>**RESOLVED**</u> Standing Order 1 (m) prohibiting the recording of Council meetings be revoked.
