

Safeguarding Policy

Introduction

We all have a duty to safeguard children, young people and vulnerable adults, preventing impairment to children's health and/or development. Everyone should take action to ensure all children have the best life chances and are growing up in circumstances consistent with the provision of safe and effective care.

This policy outlines practice that promotes the safety of children, young people and vulnerable adults using the Town Council facilities.

The Town Council has a duty to report and forward any concerns.

This policy will be reviewed by the Town Council annually.

Definitions

The definition of a child or young person:

• An individual under the age of 18 years

The definition of an adult who is at risk Anyone over the age of 18 who is:

- Unable to care for themselves
- Who is in need of community care by reason of mental or other disability, age or illness
- Unable to protect themselves from or at the risk of significant harm or exploitation

Our safeguarding policy and to whom it applies

This policy applies to anyone working for or on behalf of Liskeard Town Council whether in a paid, voluntary or commissioned capacity. Contractors will be requested to comply with our Safeguarding policy, and on some occasions, provide proof of their own policy.

The purpose of this policy is to;

- Protect children, young people and adults at risk who use the Liskeard Town Council facilities.
- Provide staff and volunteers with the overarching principles that guide our approach to safeguarding and child protection.

The Liskeard Town Council believes that no person should ever experience abuse of any kind. We have a responsibility to promote the welfare of all adults, children, young and vulnerable people and duty to keep them safe. We are committed to practise in a way that protects them.

We recognise that;

- The welfare of children is paramount, as enshrined in the Children Act 1989 and the 2004 update
- All children, young persons and adults at risk regardless of age, disability, gender, ethnicity, religious belief or non-belief, sexual orientation or identity, have a right to equal protection from all types of harm or abuse
- Some children, young people and adults are additionally vulnerable because of the impact of previous experiences, their care needs, communication needs or other issues
- Working in partnership with adults, people at risk, children, young people, their carers and other agencies is essential in promoting the welfare of those groups

We will seek to keep children, young people and vulnerable adults safe. We will promote a safe environment by:

- Ensuring regular safety assessments are made and provide safe physical environment for our children, young people and vulnerable adults in all of our facilities, by applying health and safety measures in accordance with the law and regulatory guidance.
- Safeguarding expectations are made clear and written documentation is readily available for all employees, volunteers and councillors
- Providing effective management for staff and volunteers through supervision, support, training and user feedback
- Ensuring all relevant checks are made on the recruitment of new employees and volunteers
- All information will be recorded and stored professionally and securely. All sensitive information regarding safeguarding issues will only been accessed by the DSO (Designated Safeguarding Officer), and if deemed necessary the Town Clerk
- Following our safeguarding procedures to report concerns and information with the relevant agencies who need to be informed
- Using our anti-bullying policy and procedures found on section 6.3 of the staff handbook to maintain an anti-bullying environment, following out policy to help us deal effectively with any issues that may arise
- Staff will follow the whistleblowing policy outlined in section 1.5 of the staff handbook
- Valuing all children, young people and adults at risk by listening and respecting them

To ensure Liskeard Town Council does its upmost to promote a safeguarding culture in its facilities.

All persons including employees, Councillors and volunteers have a duty to protect children, young people and vulnerable adults. However they are not responsible to decide whether abuse is taking place - all concerns raised should be passed on to the Facilities Administration Assistant and Designated Safeguarding Officer (DSO), or direct to the Multi Agency Referral Unit (MARU) on 0300 123 1116 for children or the Adults Triage Team (ATT) for young a people or vulnerable adults over the age of 18 years on 01872 326433. Out of hours number for both MARU and ATT is 01208 251300. If reported directly to MARU or ATT, all concerns raised must be passed on and recorded by the DSO.

Radicalisation and extremism

Liskeard Town Council is committed to providing a secure environment with a duty to protect vulnerable all people from radicalism and extremism. Liskeard Town Council will report any concerns to the local government, Channel Panel.

Channel is a programme which focuses on providing support at an early stage to people who are identified as being vulnerable to being drawn into terrorism. The programme uses a multi-agency approach to protect vulnerable people by:

- Identifying individuals at risk
- Assessing the nature and extent of that risk
- Developing the most appropriate support plan for the individuals concerned

Social media

Employees should refer to the staff handbook, section 2.8 for guidance on computer use and social media safety.

On occasion, Liskeard Town Council may use social media to promote public events. Liskeard Town Council will make the public aware beforehand.

Whistleblowing

Liskeard Town Council follows a strong whistleblowing policy outlined in section 1.5 of the staff handbook.

We recognise that all staff and volunteers should be aware of their duty to raise concerns about the attitude, actions or behaviour of colleagues to the Designated Safeguarding Officer or Town Clerk. Allegations will be passed on to LADO (Local Authority Designated Officer) and appropriate action will be taken.

Children cannot be expected to raise concerns in an environment where staff and volunteers fail to do so.

Identifying and recognising abuse

Abuse is a violation of an individual's human and civil rights by another person or persons.

<u>Child abuse</u> is categorised in to four main types:

- Physical
- Sexual
- Emotional
- Neglect

<u>Adult abuse</u> is more diverse. It is categorised in to ten types:

- Physical
- Domestic
- Sexual
- Psychological
- Financial or material
- Modern slavery
- Organisational
- Discriminable
- Neglect/acts of omission
- Self-neglect

You may recognise abuse in a child, young person or vulnerable adult if they show the following symptoms:

- Withdrawal
- Physical changes
- Change in behaviour
- Clothes
- Hygiene

This list outlines some of the changes that someone may experience when abuse is occurring, however is not restricted to only them and other changes may be noticed.

All staff, volunteers and Councillors need to be aware of the many forms of abuse and should be concerned by any action or inaction that physically or emotionally harms a person. Abuse comes in many forms from any area of society, regardless of social class, wealth or geographical location and more than one type of abuse may be happening at the same time. All concerns should be reported to and recorded by the DSO. All concerns will be investigated by professionals - no staff, volunteer of councillor should investigate allegations.
