

MARKET MAKERS: REPORT TO LISKEARD TOWN COUNCIL, DECEMBER 2022

PROMOTIONAL ACTIVITY

The project's third business promotional event took place on the afternoon of Saturday 3rd December at Liskeard Public Hall, as part of that's day's seasonal celebrations across the town. It attracted approximately 150 visitors and featured the work of 14 client artists and creative enterprises.

MP for South East Cornwall Sheryll Murray attended the show and said: 'It's superb to see so much hidden talent in southeast Cornwall. I'm amazed at the professional paintings, glasswork and other crafts that I've seen today, and I think Market Makers have a lot to offer to the Duchy. It's also interesting to learn that many small businesses have started in this way.'

Much recent promotional work has focused on the achievements of the project's client members and enterprises, and on the broader business promotion of destination Liskeard. The following stories have appeared in the local press since the project's last report to LTC:

In addition, the project has published the sixteenth and seventeenth issues of its regular newsletter since the November report to LTC.

The project currently has 75 mailing list subscribers, 89 followers on Twitter, 144 on Instagram and 448 on Facebook.

A door-to-door leafletting campaign in the project's core areas is ongoing.

ESF O1

Recruitment of ESF O1 participants remains challenging, not only for this project but across the CLLD reach and the national ESF sector. Costs associated with ESF O1 have been significantly reduced in order to reduce risk: weekly sessions continue but currently with zero administrative support costs and teaching support costs.

It was noted at the CLLD projects briefing meeting on 14 December 2022 that CLLD have informed the Managing Authority of participant recruitment issues across the board and are hoping that 'original contracted outputs [...] will be reduced very soon'. At that briefing meeting, CLLD also apologized for ongoing delays in their processing and response to submitted participant documentation.
