#### 560/13 APPLICATIONS FOR CONSIDERATION

PA13/009296 Aster Homes on behalf of Tan Properties Ltd, Land Adjacent 29 Trevillis Park

Application for Modification of a Section 106 planning obligation.

The Town Clerk explained that lenders were not happy about the wording of some of the conditions; they felt that it would reduce the potential value of the houses. Councillors thought that as the houses were designated as affordable/social in the planning application this description should remain. They did not understand the reasons for this application.

Councillor Mallard proposed, Councillor J. Shrubsole seconded and the Committee **RESOLVED** that the Council **OBJECT** to the application as the reasons for the change were not clear. If more information was provided, they would reconsider the matter.

## 1. Rapsons car Park

Councillor Hawken informed the meeting that, as a Cornwall Councillor, she had been asked by the Cornwall Council Asset Management team to obtain the Town Councils opinion on their consideration of selling the unviable Rapsons car park for housing.

Members were concerned that the Council had not been approached by Cornwall Council and that the matter was not on the Agenda. Members were not prepared for this discussion and thought it was maladministration that the Council had not been informed officially, by anyone. Members thought that the land had been gifted to the Town with a covenant that it would always be available for public use. This was discovered by the local Planning Authority when the Rifle Club wished to develop the site.

Councillor Mallard proposed that the Town Clerk should write to Cornwall Council to

ensure they are aware of the covenant on the Rapsons land

- that this Council considered that the balance of the housing stock was towards affordable/social housing, they would wish for a mixed housing stock
- ensure that this Council would be officially informed of any proposals for this land
