The footpath will be adopted by Cornwall Council in due course. Contract administration is being undertaken by Martin Perry Associates, Structural Engineers and Surveyors on behalf of the Town Council. Councillor

Goldsworthy proposed, Councillor Ambler seconded, and the Committee APPROVED the

quote for the sum of £21, 051.60 + VAT and that the balance be drawn from the Parks and Open Spaces Reserve as the quote exceeds the earmarked budget.

42 / 21 <u>DEVOLUTION</u> – Councillor Smith provided a verbal update on the devolution programme. The Town Council has submitted a list of proposals to Cornwall Council and is particularly keen to progress proposals relating to Castle Park and Rapson's Skatepark and MUGA. Castle Park has received recent investment via the Making Space for Nature Project. The Parks and Open Spaces Working Group is working on the proposals for Castle Park and Rapsons Skatepark and MUGA in more detail, including identifying operating costs and statutory obligations such as tree management. The next Working Group meeting will take place at 7.30pm on Thursday 8th July 2021.
