He stated that Highways had made a technical survey of the roads and did not agree with our opinion that there would be problems in the future, and that he did not agree that the development was over intensive as the proposal contained large gardens and open spaces, the layout of the development was similar to the existing estate and that the two story houses would not be built next to existing bungalows. The proposed building materials were compatible with the existing.

The Committee discussed these comments and what action could be taken. Members referred to the Protocol document circulated earlier and were reminded that they could only object on the grounds of the items they had originally objected to.

Councillor Purdon proposed, Councillor Hodgkins seconded and the Committee <u>**RECOMMENDED</u>** that the Council <u>**AGREE**</u> to **DISAGREE** with the Planning Officers decision.</u>

5. It was stated that we would only be informed of the application for the Travellers Site in an ajoining Parish, if those Councillors wished to receive our opinion.
