6. REMEMBRANCE DAY - ROAD CLOSURE (ATTACHED – ROAD CLOSURE MARSHALLING REPORT AND SPECIFICATION AND COMPANIES APPROACHED) - To report on the quotes received so far to close the roads associated with the remembrance parade this year in Liskeard.

<u>Background</u> – The Town Council at its 29th November 2022 meeting considered the latest guidance (attached) on the importance of supporting marking Remembrance Day, through the joint holding of parades and services.

The Town Council decided as set out in the minute below:

"Minute 341 / 22 REMEMBRANCE DAY PARADES (LATEST JOINT GUIDANCE ATTACHED) – The Mayor proposed, Councillor Reid seconded and the Council RESOLVED to approve the Town Council organizing the Parade as a "Civic Event" for the purposes of risk assessments and road closures with the help of the Royal British Legion and Liskeard / Looe Lions.

<u>Update</u> – this year, owing to circumstances (including issues impacting carrying out road closures) the Liskeard / Looe Lions are this year not carrying out the usual Carnival thorough the streets. They are instead holding a "Fun Day" in Castle Park. This format would have cost benefits as well as being easier to organise and safer for those taking part.

<u>Road Closure</u> – Given the issues that the Liskeard / Looe Lions were facing the Town Council has sought costings from 5 companies / Community Interest Companies that specialise in road closures and event management. At the time of writing two quotes had been received which are attached as PARTII items and can be discussed in the public session as Contractor A and Contractor B. If detailed discussion is felt to be necessary, this can be done in PARTII.

<u>Road Closure Notices</u> – Cornwall Council asks for these to be submitted 12 weeks / 3 months before the date of the event. This submission needs to contain the necessary insurance information relating to a specific company or organisation requiring the road closure. This means

that the 29th August Council meeting would be too late. The notice should ideally go in later in the week of the 8th August 2023 Special Council.

<u>General Reserve</u> – for this year the cost for the road closure be taken from the General Reserve and in future years budgeted as a "Civic Event"
