502 / 20 MAYOR'S REMARKS – This is our last Full Council meeting of the current term. It's the end of four years, with Christina as Mayor for the first two and then me.

It hasn't always been easy, especially the last year. Partly as a result of the pandemic and the ways we have had to operate, relationships have become strained. But over that time we have worked together to achieve a lot. The Neighbourhood Plan was overwhelmingly agreed at referendum and we have worked to uphold and implement it. We've played an active part in the plans for the renovation of the old Cattle Market to benefit our community and local economy. We were the first organisation to commit funding to Liskeard Together, which is providing such vital support to local people in deprivation and will be featured as a case study for the European Social Fund. We have run and participated in many community events, including Liskeard Unlocked, Nadelik Lyskerrys and vastly increasing participation in the Community Fair and the Annual Meeting. We've renovated our Public Hall and made it much more accessible.

Congratulations to everyone who stood and was elected unopposed. In May we will welcome four new councillors, Kerry Cassidy, Nick Craker, Richard Dorling and Annette Lee-Julian. Steve has contacted them all and invited them to the meetings on 13 and 18 May.

Five councillors, who have all brought a lot to the council in different ways, are standing down.

Sandra Mitchell has been Deputy Mayor for the last two years. It's no secret that we haven't always seen eye to eye but what I've never lost sight of is the huge amount of valuable work she does in the community and how as a town councillor that has enabled us to connect with local organisations and people. She has done brilliant work, for example, on the Community Fair and, more recently on bringing together organisations to coordinate food for people in need.

We are losing Sally Hawken not just as a Town Councillor but as a Cornwall Councillor and Liskeard will really miss what she has done, often behind the scenes, to make connections and raise issues so that we can achieve our aims. As she has been playing a pivotal role in how Cornwall has come so well through the pandemic, it has amazed me how she has also found time and energy to focus on Liskeard issues. Sally is both a strategic thinker and someone who gets very practically involved, whether that's in casework or painting old buildings and she's made a huge contribution to the Town Council in the last eight years.

Anna Clarke is someone else with really strong links in the community, which she has been able to bring to her role as Vice-Chair of Communications and Engagement. She was the person who came up with the idea of the very successful Community Champion awards and has done a lot of work on connecting with young people.

Sue Shand has been responsible for completing the Community Emergency Plan and has played an active role on both the Planning Committee and Communications and Engagement, including work on accessibility.

lan Barlow has brought a strong environmental focus to the Planning Committee and Communications and Engagement, including his contributions to the active travel plans.

To make things happen in Liskeard the Town Council relies on a much wider network of people and organisations and I really hope that though these five people are standing down from the Town Council they are not standing down from community involvement and we will have the chance to work with them in the future on the many challenges we face.

I'd like to thank you all for everything you have done for the Town Council and Liskeard over the last four years. Also, as ever, I'd like to thank the staff team, led by Steve, for all their hard work, enthusiasm and commitment.

This to include the area covered and possible actions for the consideration of the Town Council and partners.
- 517 / 20 <u>WAR MEMORIAL</u> The Mayor and other councillors reported on the very constructive meeting with the Royal British Legion and Cormac. In discussion the point was made that the area of Castle Park for devolution to the Town Council by May 2022 did not currently include the grassed area owned by Cornwall Council around the War Memorial. The Parks and Open Spaces Working Party was asked to bring back a recommendation on this to Council. The Mayor proposed, Councillor Cassidy seconded and the Council <u>RESOLVED</u> to support the setting up in late May 2021 of a Community Interest Group to discuss making Remembrance in Liskeard as accessible and fitting as possible, including the siting of the war memorial.

DPDATE ON VIRTUAL MEETINGS USE BEYOND 7TH MAY 2021 — The judgement in the court case is due this week. This might modify the outcome of the Councils' discussions. It was noted that the advice of the Cornwall Association of Local Councils (CALC) was that informal meetings and meetings of working parties can continue to be held by virtual means should the circumstance imposed by Covid dictate.

Following extensive discussion, including the need for a revised Risk Assessment of the return to the holding of Council and Committee meetings in the Public Hall, by an informal poll Councillors indicated by 6 v 3, that they would prefer a return to the holding of actual face to face meetings.
