What do you need the money for?	<p>WE HAVE NOT BEEN ALLOWED TO OPERATE SINCE 23 MARCH DUE TO THE CORONAVIRUS RESTRICTIONS, AS THE NATURE OF OUR SERVICE IS BEING ONE-TO-ONE WITH PEOPLE IN THE VULNERABLE SECTOR.</p> <p>OUR MONTHLY OUTGOINGS, WHICH INCLUDES OFFICE RENT TO CORNWALL COUNCIL AND PAYMENT OF THE TELEPHONE SERVICE, REMAIN THE SAME, WHICH IS CAUSING PROBLEMS AS WE ARE UNABLE TO GENERATE ANY INCOME, AND OUR BANK FUNDS ARE RUNNING LOW.</p> <p>YOUR EMERGENCY FUND WOULD PROTECT OUR BUSINESS AND SAFEGUARD THE SERVICE WE PROVIDE FOR THE FUTURE.</p>

Is it aimed at specific groups?</p>	<p>THE SERVICE WE OPERATE IS SPECIFICALLY DESIGNED FOR THE RESIDENTS OF LISKEARD, TO TAKE THEM TO HOSPITALS, DOCTORS OR ANY MEDICAL APPOINTMENTS. GENERALLY OUR CLIENTS ARE RETIRED, OFTEN IN POOR HEALTH AND WITH MOBILITY PROBLEMS, MAKING PUBLIC TRANSPORT USE IMPOSSIBLE.</p> <p>WE OPERATE ON A ONE-TO-ONE BASIS; OUR VOLUNTEER DRIVER CALLS FOR THE CLIENT AND THEY TRAVEL DIRECTLY TO THE APPOINTMENT. THE CLIENT HAS THE REASSURANCE THAT THE SAME DRIVER WILL BE WAITING FOR THEM WHEN THEY ARE READY TO RETURN HOME.</p> <p>WE BELIEVE OUR SERVICE IS UNIQUE, AS WE HAVE ONLY ONE CLIENT IN THE CAR; THIS AVOIDS ANY DELAY IN JOURNEY TIMES AND WAITING PERIODS, AS WOULD BE THE CASE IF OTHER PEOPLE WERE CALLED FOR EN ROUTE TO THE APPOINTMENT.</p>
