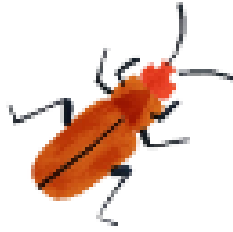

Making Space for Nature

Goals

- Increase biodiversity
- Improve access
- Engage local communities
- Provide value for money



Project Details – GI4G2

- Grant funding **£2.9m** total - ERDF £2,339,624, Cornwall Council £551,591, University of Exeter £33,315
- 28 hectare target area
- Aug2019 to Dec 2022
- **Just seven towns**
 - Bodmin
 - Falmouth
 - Launceston
 - **Liskeard**
 - Newquay
 - Penryn
 - St Austell



Site Selection

- Owned/managed by Cornwall Council
- In condition that can be improved for biodiversity and access
- Open access to all
- Choice supported by Cornwall Councillors and Town/Parish Councillors and residents – prior consultations e.g. neighbourhood plans can be evidence of this
- Feasibility of long-term management
- Equitable distribution of budgets across 7 towns
 - £200K per town
- Liskeard = 5.7 ha over 3 sites



Site Process – a recap

- Site selection
- Consultation and design
 - Design principles – sustainability in local context/ wildlife/ wellbeing/ climate and water
- Construction: implementation of new habitats and access improvements
- Establishment enhanced management, ERDF funded
- Environmental Growth Management Plan for each space
- Long-term management commitment - 15 years



Liskeard Neighbourhood Development Plan

“Liskeard has a good supply of green spaces but they have lacked management or investment”

- Protect, conserve and enhance green spaces with heritage significance
- Open space as a ‘Health and Wellbeing’ asset for all ages
- Greater sustainable connectivity to open spaces, with improved accessibility
- Green corridors as key elements of Green Infrastructure
- Liskeard as a destination

Update Feb 2021

- **St Martins Church Yard (1.5ha):**
works undertaken Nov 2020
- **Lanchard Woods (1.8ha):**
works undertaken Nov/Dec 2020
- **Castle Park(2.4ha):**
works on-site for ~9 weeks
from 8th Feb 2021

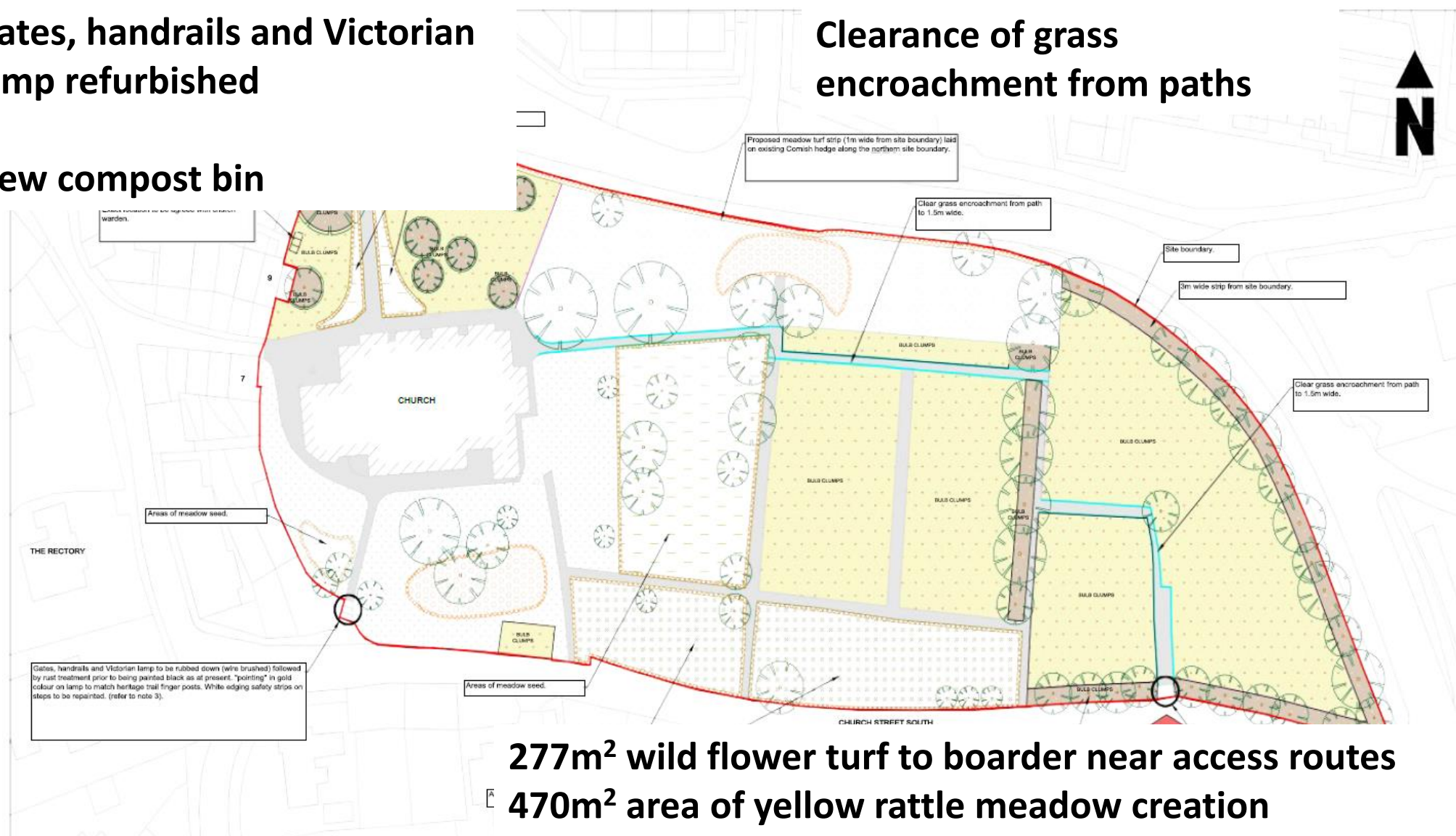


St Martins Church Yard (1.5ha)

Gates, handrails and Victorian lamp refurbished

New compost bin

Clearance of grass encroachment from paths



277m² wild flower turf to boarder near access routes
470m² area of yellow rattle meadow creation
1154m² Area of meadow created through scarification and wildflower oversowing

- Woodland management

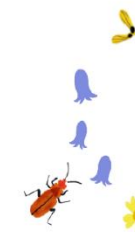


Woodland management consultation closed 22nd Feb

Castle Park (2.4ha)

- Consultation Autumn 2020
 - Letters to residents of Lake Lane estate, Park View, Park Lane and Pengover & Liskeard Together event.
- Planned end of works – end April (*weather/covid dependent*)
- Currently in landscaping/beginning of planting phase
- CC health and safety visit 16th Feb – no actions, excellent score
- Communications
 - 100 advance works letters sent to residents 21st Jan
 - Signage on site stating the site remains open → areas will be cordoned-off for safety



Building with Nature

- MSfN project funding requirement to gain an accreditation through assessment
- Building with Nature goes beyond the statutory requirements
- **Standards = Core (sustainability in context)/ Wildlife/ Wellbeing/ Water**

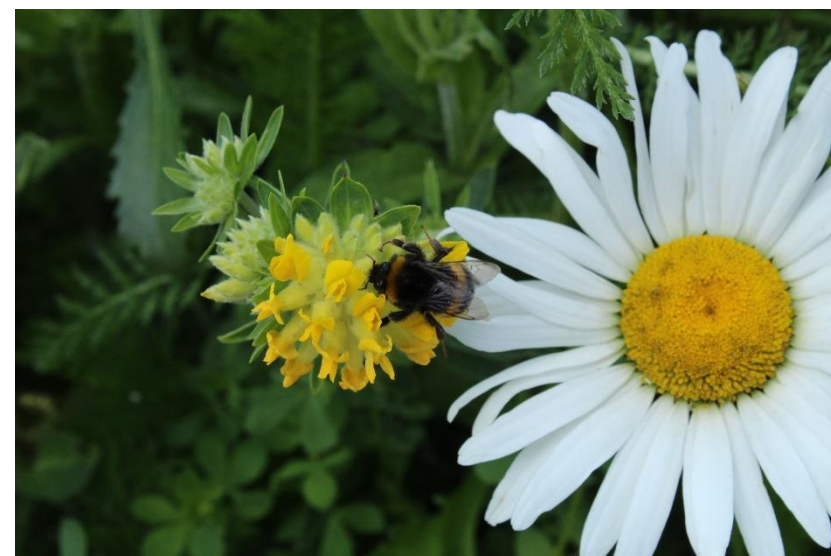
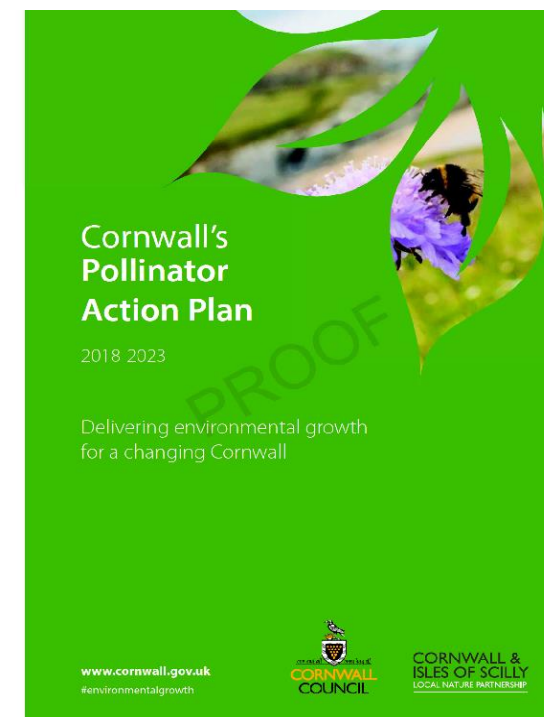

Carbon Neutral Cornwall 2030



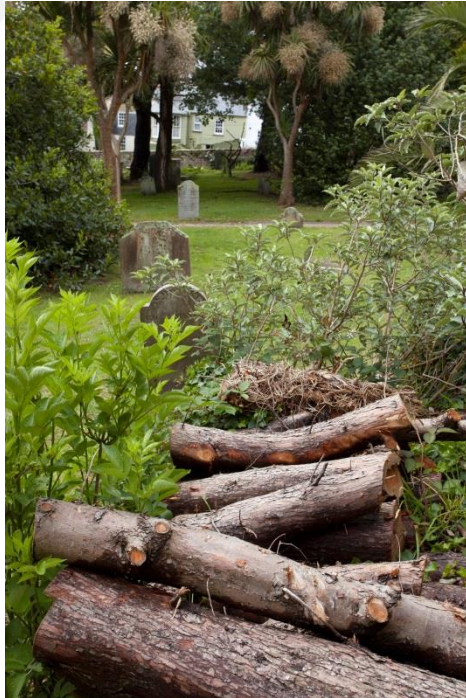
- 22 Jan 2019 Cornwall Council declared a **Climate and Biodiversity Emergency**
- 24 July 2019 Cabinet approved the Action Plan to work towards becoming **carbon neutral by 2030**
- 17 Dec 2019 'Forest for Cornwall' launch with the aim to have 8,000 ha of canopy cover

Engagement and Sustainability

- The sites are community assets – we want them to be cherished
- We have sought and listened to community feedback
Liskeard Unlocked; postal and online consultation; town and CCLrs
- Facilitate ongoing community stewardship through supporting physical engagement **e.g. Friends of Castle Park/Lanchard Woods Groups**
- Monitor impacts
- The effectiveness of this project can help inform future initiatives
