
As one gets older circumstances can change very quickly, and I find that what I can do today I might not be able to do tomorrow.



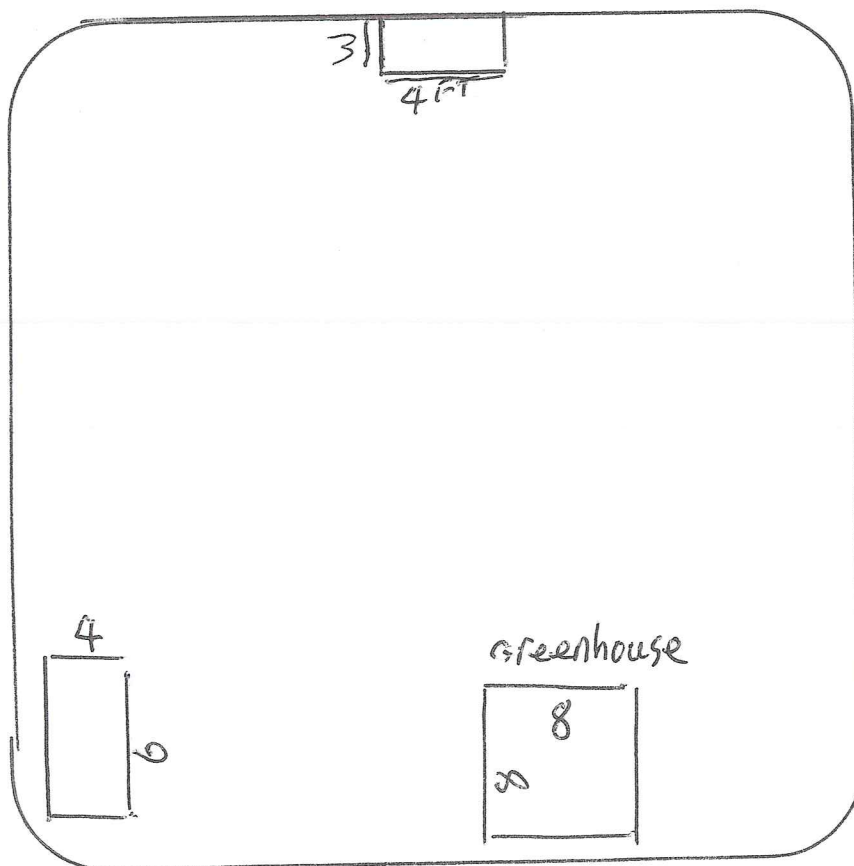
erect a 3ft x 4ft Shed on my allment at Pengover.
