The Chair opened the meeting and advised those present of housekeeping matters.

347 / 20      **APOLOGIES** – None.

348 / 20      DECLARATIONS OF INTERESTS, REGISTERABLE AND NON-REGISTERABLE – None.

349 / 20      **MINUTES OF 17<sup>th</sup> NOVEMBER MEETING:** – Councillor Smith proposed, Councillor Pascoe seconded and the Committee **APPROVED** the minutes of the meeting held on 17<sup>th</sup> November 2020.

351 / 20      **FACILITIES MANAGER'S REPORT** – The Facilities Manager's report was noted by the Committee.

352 / 20      **BUDGET MONITORING** – to budget monitoring report to December 2020 was noted by the Committee. Note – to ask if weed spraying payments are complete and update on the Re-opening High Streets Safely Fund grant application.

353 / 20      **GUTTER CLEANING & MINOR REPAIRS FOR GUILDHALL, FORESTERS' HALL AND PUBLIC HALL** – to approve the quote received for £2,307.00. Councillor Ambler proposed, Councillor Pascoe seconded, and the Committee **APPROVED** the quote of £2,307.00, subject to receipt of two satisfactory references.

Councillor Smith had to leave the meeting briefly so agenda item 8 was deferred.

354 / 20      **ACCESSIBLE ALLOTMENT PROVISION** – to explore opportunities with the developer for accessible allotment provision as part of the Trevethan Meadows Phase 4 Development. Councillor Ambler proposed, Councillor Brooks seconded, and the Committee **APPROVED** further discussion between Facilities Manager and the developer around accessible allotment provision at Trevethan Meadows.

355 / 20 **PARKING SPACE IN WESTBOURNE CAR PARK** – to provide a parking space for potential use of disabled councilors, staff and visitors and further investigate provision of additional spaces in the long-stay car park (formerly Avon Farmers site). Councillor Smith proposed, Councillor Pascoe seconded, and the Committee voted 4 for in favour and 4 against with the Chair having the casting vote. The proposal was not carried.

356 / 20 **ADDITIONAL LITTER/DOG WASTE BIN** – to support the installation of a litter dog/waste bin on the footpath at the junction of West Street and Old Road, provided with funding from Councillor Pascoe and Councillor Craker via the Community Chest Grant and approve a budget for 2021/22 for the weekly collection from all three recently installed litter/dog waste bins located at Moorswater, Lake Lane and West Street at an approximate annual cost of **£780.00** plus VAT. Councillor Ambler proposed, Councillor Brooks seconded, and the Committee **APPROVED** an annual budget of **£780.00** plus VAT for the collection of waste from litter/dog waste bins.

357 / 20 **APPROVE THE 2021/22 FACILITIES BUDGET** – to approve the 2021/22 budget as presented with the **£780.00** for litter/dog waste collections off-set against reserves so maintaining a neutral budget. Councillor Smith proposed, Councillor Goldsworthy seconded and the Committee **APPROVED** the 2021/22 Facilities budget as presented with the **£780.00** for litter/dog waste collections off-set against reserves.
