087 / 22 **MAYOR'S REMARKS** – The Mayor spoke on the following:

- 3rd July 2022 – Civic Event Methodist Church - The Mayor thanked all those Councillors who had attended.
- Liskeard Show – The Mayor was pleased to report that the Liskeard Show was well attended. He thanked all those Councillors who had been on the stand. He also thanked those Councillors who had helped transport, set up, take down and bring back the stand. Councillors Dorling, Goldsworthy, Pascoe and Whitty were mentioned.
- Floral Displays – The Mayor praised all of those who had put in some much effort to the floral displays in advance of the inspection visits. However, the volunteers of the Liskeard in Bloom team were mentioned in particular.

089 / 22 **CREATIVE INCUBATOR PROJECT** – To consider the proposals to provide a Creative Incubator project by purchasing and installing equipment in a suitably modified space.

The Chair of the Cattle Market Makers Board spoke to the background to the paper before Council including:

- ERDF/ESF revenue projects progressing well and generating a need for a creative incubator.
- Plans A & B had their own respective advantages and disadvantages.

Questions:

- Security Plan B – was within a building with its own alarm system and was a secure unit.
- CLLD programme management supportive of the project (72% proposed)
- Match funding 38% - if not already confirmed - too late to submit a new application to Cornwall Council for match funding. 24/22

- Revenue Projections – for the project for first and year and for five years would be needed.
- Procurement regulations – it was not apparent that this last in the day those could be met.
- Capital Project Abortive Fees Costs – this might already be £20,000 - £30,000, hence there was too much cost associated with the project.

In discussing the wording of a motion, the inclusion of the proviso that, this was subject to the confirmation of the availability of match funding and the provision of the all-necessary financial information to the next meeting of the town council. Councillor Brooks proposed, Councillor K Cassidy seconded that the Town Council submit the Plan B Creative Incubator proposal. However, this motion was defeated.
