430 / 23      **PUBLIC PARTICIPATION** – Melissa Ralph – Making Space for Nature Manager (Urban Green Shoots – see agenda item 14). Spoke to the presentation previously circulated and the Sun girt update which had just been circulated. The key-points and questions were:

- Volunteers – the importance of building the volunteer base to help sustain the project which will have site investments during the period to 2025, but do not having ongoing revenue support.
- Anti-Social Behavior – could be reduced by improving the visibility of the site by pruning to the holly tree (which adjacent resident supported and would help monitor on an ongoing basis) and topping off the conifer trees forming the boundary treatment.
- Accessibility – the current path leads to start of the walkway. However, it appears to be sufficiently level to made up to an accessible to the South West Water facility.
- Sun girt Car Park – especially the lower car park was in need of a “spruce up”.

443 / 23      **CORNWALL COUNCILLOR UPDATES** –

#### **CORNWALL COUNCILLOR JANE PASCOE**

Cllr Pascoe raised her concerns regarding the decision by Cornwall Council to trial cessation of the acceptance of DIY Household Waste, TILES, RUBBLE, PLASTERBOARD, SANITARY WARE AND TYRES at Connon Bridge. East Taphouse. The consequences had already resulted in an increase in fly tipping and longer journeys for residents to dispose of their DIY Waste. Alternative facilities are as far as Tintagel, Saltash or St Austell. This may increase traffic on the sub standard A38 and add to the pollution to the roadside village of Tideford.

She asked the Council if they would consider writing to Cornwall Council to request they review the decision.

Councillor Smith proposed, the Mayor seconded and the Council **RESOLVED** to write to Cornwall Council regarding the cessation of allowing Connon Bridge to take Household DIY waste.

Waste and Recycling Bin Rollout has commenced in SE Cornwall and has been running smoothly. There have been a few mistakes, most have been rectified as soon as reported  
Councillor Pascoe attended the Cornwall Recycle Waste Roadshow in Liskeard Library and recommends residents to attend the roadshow if they have any queries or issues. The next Road show is at Liskerret Centre. Liskeard on 8th March 10am to 12 noon.

The recommendation to request an increase the Tamar Crossings Tolls from the Secretary of State was considered at Cornwall Council this week. Cllr Pascoe did not vote for an increase explaining that the 3rd highest users in SE Cornwall was Liskeard and the surrounding villages. The vote to increase was won by 38 to 36 against. It was agreed the application to the SofS will be delayed for 50 days to give the MPs more time to get a response form their request for Government contributions to enable freezing the tolls.

Cllr Pascoe reported she was pleased to attend the planting of the commemorative trees in tribute to the children and young people that have been lost to Liskeard.  
She also attended the Civic Service at the Methodist Church and met many of the residents. In her role as Chairperson of the SE Cornwall Area Partnership she attended the opening of the front desk at Looe Police Station, a welcome facility for the local community and visitors to Looe.

Gypsy, Travellers and Romas Consultation is currently on-line at CC "Lets' Talk" website.

The next meeting of the SE Cornwall CAP is on Tuesday 5th March at 6.00pm when 29 parishes will meet virtually to share good practices and difficulties encountered.

She talked about attending the most fitting funeral of a Councillor Edwina Hannaford. Edwina was an outstanding Councillor and will be hugely missed by so many people in Looe and from wider Cornwall. She contributed to many policies and documents used at Council and she will always be remembered.

#### **CORNWALL COUNCILLOR NICK CRAKER –**

- Cornwall Council budget approved, a 2.99% increase plus 2% for Adult Social Care
- Cornwall Council's housing rents also increasing by CPI +1% to address severe maintenance backlog and invest in energy efficiency improvements
- 800 families in emergency accommodation, an increase of 100 since last year. Cornwall Council has a legal duty to find emergency accommodation for these people.
- Cornwall Council continuing to buy and build its own homes, including in Liskeard.
- Homechoice is highly subscribed but continues to prioritise local people with a local connection to Liskeard, neighbouring parishes or Cornwall wide.
