572 / 22 <u>CORNWALL COUNCIL CCTV MONITORING RESPONSE (ATTACHED)</u> – Following an update and discussion, it was agreed the Council should continue to monitor the situation and support the development of options going forward with the emphasis on joint working to achieve economies of scale and involve key partners such as, the Police and Safer Liskeard.

573 / 22 CORONATION CELERATIONS ILLUMINATION – UPDATE (MINUTE 508/22 28TH FEBRUARY 2023 COUNCIL. – The Town Clerk clarified that the permanent illumination at the Guildhall had been considered by the Facilities Committee during its budget setting last year. It was considered beneficial in several respects. However, the Public Hall Phase 2 Refurbishment (including toilets etc.) had been considered a more urgent project to progress as part of the programme of works. Since, then last months' Council meeting had agreed to support "Commemorative Lighting" with new funding taken from the reserves. The original Guildhall permanent lighting proposal appears a cost-effective approach compared with a temporary illumination. The owner of Webb's House had just agreed to that element of the proposal.

It was decided to obtain:

- Other quotes for the temporary lighting solution over the places (Guildhall, Fountain and front of the Webb's House).
- Other quotes for the permanent lighting solution to the Guildhall only.

(Check if there had been an earlier version of the Guildhall lighting at £1,200.) Given the very short timescales, the Mayor confirmed that a Special Council might need to be held.

Councillors Ambler and Goldsworthy returned to the meeting.

574 / 22 <u>COUNCIL MEETING FREQUENCY (MINUTE 508/22 – 28TH FEBRUARY 2023 COUNCIL)</u> – Councillor Dorling proposed, Councillor Lee-Julian seconded and the Council <u>RESOLVED</u> to retain the holding of monthly Council meetings rather than alternating Council and Finance, Economic Development & General Purposes Committee meetings in successive months.

575 / 22 CORNWALL COUNCILLOR UPDATES: Nick Craker:

- Devolution deal for Cornwall consultation results were now published. 69% of public were against the deal, specifically a new governance model with directly elected mayor. However, a representative survey of 1,000 people from across Cornwall indicated support for the deal. This would now be sent to Cabinet and then Full Council for a decision on what to do next, including a decision on whether a referendum is required.
- <u>Electric car charging points</u> had been installed in Westbourne and Sungirt with Rapsons due to follow soon. Cornwall Council had match funding from the ERDF.
- <u>Liskeard Library</u> had been granted funding from SPF to complete the library refurbishment, expected completion end of 2023, all being well.

 <u>Liskeard WorkShed</u> construction delayed again, completion now expected end of June 2023. Daniel from Foundry Asset Management is now in post to manage the co-working space and outdoor events area, he would be at the community fair to talk about the plans for the WorkShed.

Jane Pascoe:

- Fire & Rescue Critical Control Centre
 Following a robust review Neighbourhoods Overview and Scrutiny Committee voted unanimously for the Fire & Rescue Critical Control Service Centre to remain in Cornwall.
- <u>CCTV Monitoring Service</u> A further review will be undertaken for the CCTV Monitoring service at Tolvaddon and the Towns that use the services will be consulted.
- <u>Liskeard and Looe Community Network Area</u> The last meeting of the Liskeard and Looe Community Network Area will be at Lanreath Village Hall on 24th April 7.00pm, this will be an informal face to face meeting and a chance to network with the other parishes and discuss the next steps for our future amalgamation with the Gateway CNA.
- <u>Car Parking Charges Changes</u> Cllr Pascoe continues to object in the strongest terms regarding the changes to the car park tariffs, including the new tariff for Sundays.

The same items raised were still valid – he is already recognised by the late Queen with the award of an M.B.E., already has recognition in the naming of the industrial estate road after him (as Chair of the Employment Committee which commenced the project), is it the correct use of the Blue Plaque Scheme in any case, a number of past Mayors' (and other people) have done a lot for the town over the years at what point do you draw the line/. – The correspondence was noted.
