Councillor Haley proposed, Councillor Raines seconded and the Committee **RESOLVED** that the Council **SUPPORT** the application, subject to the layout retaining the ability to connect to the proposed bridge to the southern side of Lake Lane.

Councillor Shand proposed, Councillor Raines seconded and the Committee **RESOLVED** that the Council **SUPPORT** the application. A local observation that the slope of the bin store roof would look better reversed was noted.

#### PA17/05785 - Mr Roger Matthews, 21 Gipsy Lane

Works to trees covered by a Tree Preservation Order, namely fell a Pine tree designated T12

Councillor Haley proposed, Councillor Whitty seconded and the Committee **<u>RESOLVED</u>** that the Council **<u>SUPPORT</u>** the application, subject to compliance with the recommendations of a tree officer, and replacement with a sapling.

### <u>173/17 Community Infrastructure Levy (CIL) Consultation (12 June – 7 August</u> 2017)

To agree a response to the 5 proposals of the latest consultation on the Draft Charging Schedule

The Committee noted there was still a lack of clear information, particularly on the decision making process for how the monies raised are spent. Liskeard remains in area 5, where no CIL will be levied for house building, and concerns were raised about how infrastructure projects would therefore be funded. The Committee welcomed the new Draft Regulation 123 List which had been released, and noted under emergency services it included a possible tri-service in Liskeard. The Committee will respond accordingly to the consultation.

### <u>174/17 2017 Off-Street Parking Consolidation Order Consultation (29 June - 26 July 2017)</u>

The Committee supported the proposals in the consultation, but would continue to strongly resist the introduction of evening parking charges in the Town carparks.
