542/16 NEIGHBOURHOOD PLAN

To consider a recommendation to Full Council that the draft plan with enclosed amendments are approved for submission to Cornwall Council for regulation 16 Consultation

The Chair of the Neighbourhood Plan Steering Group Councillor J Shrubsole reported that since the public consultation the group had completed detailed analysis of the responses, resulting in some amendments to strengthen or clarify policies.

Cornwall Council (CC) had indicated they believed the document too long, taking more time for a planning officer to read through and pick out the relevant points, and the background information was not required. However, the group felt that this set the Plan in context and meant that it could be read by a member of the public as a stand-alone document.

Once submitted to CC they will consult again with those people who were consulted, and also refer it to the relevant legal departments. It will then be submitted to an independent examiner appointed by CC. Once it has passed these stages it will be assembled in its final form for a referendum.

The Mayor thanked Councillors J and L Shrubsole and the rest of the group for the substantial amount of work they have contributed to the Plan.

Councillor J Shrubsole proposed, Councillor Pascoe seconded and the Committee **RESOLVED** to **RECOMMEND** to Council that the draft plan with enclosed amendments are approved for submission to Cornwall Council for .3.
