Mrs Mann spoke with reference to the item of correspondence she had submitted. She asked the committee to write to Persimmon to urge them to complete their outstanding obligations under the planning permission of phase 3 before commencing phase 4. In particular, she was concerned about two Cornish hedges and associated planting and fencing, required to design out crime, which had not yet been provided, to the detriment of residents who were experiencing some trespass and petty vandalism. Unfortunately, the planning permission had not included a timetable for provision and therefore the onus was on the developer as to when to fulfil the obligation.

Councillor Craker reported that enforcement was dealing with several items relating to this development and had given the developer until the end of July to complete the outstanding works before moving to the next stage in the process.

While the committee acknowledged that the previous conduct of an applicant was not material consideration for objecting to future applications, in representing and protecting the interests of the people of Liskeard, they would write to the developer urging them to complete their outstanding obligations and advising that they would be reluctant to support any future applications the developer was bringing forward until they had demonstrated integrity in fulfilling its commitments and goodwill to neighbouring residents. The letter would be copied to the planning officer, enforcement team and Cornwall Council ward member.

Advertisement Consent to display illuminated crest on aluminium plate to first floor of east elevation.
