Additional Hotel Accommodation in the form of an annexe block with alterations to car park and associated works (including installation of air-conditioning plant compound) and small reconfiguration of main hotel

Councillor Powell proposed, Councillor Barlow seconded and the Committee **RESOLVED** that the Council **SUPPORT** the application, subject to direct discussion with the applicant on specific aspects of the sustainable energy strategy report, and the travel plan with a view to seeking the inclusion of more sustainable features within the development.

**PA19/05517 – Mr J Tucker, Land off Eddystone Rise**

Construction of single dwelling and provision of parking space

Councillor Bennetts proposed, Councillor Shand seconded, and the Committee **RESOLVED** that the Council **OBJECT** to the application for the following reasons:

- The pedestrian and vehicular access, via an existing garage forecourt, was undesirable, and likely to give rise to conflict with users of the confined garage area.
- It was considered a cramped development, which did not blend with the general scene and character of the area.

**PA18/11093 – Mr Simon Wagemakers Persimmon Homes (Cornwall), Land at Addington (accessed from) Callington Road**

Reserved matters approval for the construction of 150 dwellings including 47 affordable homes, landscaping, roads and associated infrastructure. (Details following Outline Consent PA10/03248 dated 25/11/13).

The committee agreed that the principle of building on this site was not contested, however in its current form the development as proposed would not benefit the town. Councillor Powell proposed, Councillor Taylor seconded, and the Committee **RESOLVED** that the Council **OBJECT** to the application as the applicant had failed to submit revised plans to address concerns raised on the following points:

- Specification for the boundary fence acceptable to the residents
- Details of the ongoing security and management of the mitigation corridors
- Roof heights and design for houses backing on to the existing bungalows
- Police security concerns for paths and gates
- Cramped car dominant layout
- Accessibility within the site and connectivity with the town and amenities
- Inclusion of sustainable features
- The proposal did not comply with policy 12 of the Cornwall Local Plan and policy H9 of the Liskeard Neighbourhood Development Plan.
