

Section 14(1) of the Road Traffic Regulation Act 1984 (RTRA 1984)

Temporary Prohibition of Traffic Order 2020

- The Cornwall Council makes this Order in exercise of its powers under section 14(1) of the RTRA 1984 over an
 area of highway being Road From Post Box Cottage To Junction North Of Lodge Cottage Liskeard between its
 junction with Lodge Hill and grid reference SX 248028:63366 as highlighted in red on the plan attached to this
 Order.
- The Order shall come into operation on 2nd March 2020 and shall remain in force for three months, however, this order can be extended by the Secretary of State for Transport. The works are expected to be completed by the 6th March 2020.
- 3. The prohibition will be in force 24 hours a day weekdays only.
- 4. The restrictions imposed by this order shall remain in force on such days and during such times as the appropriate traffic signs are displayed. In this order "traffic sign" means a sign of any size, colour and type described or authorised under or having effect as though prescribed or authorised under section 64 of The Road Traffic Regulation Act 1984.
- 5. The Council is satisfied that the Order is needed because works are being executed on or near the road to remove vegetation and replace fencing.
- 6. While the Order is in operation traffic, including bicycle movement, along the highway specified in paragraph 1, will be temporarily restricted. No personnel, except upon the direction of a police constable in uniform, cause or permit any vehicle or pedal cycle to enter on, proceed or wait in the length of highway described above.

Nothing in the Order will apply to:

- a. Any police, fire brigade, ambulance or coastguard vehicle, or any personnel on official duty, or any vehicle or person authorised by and with the permission of Cornwall Council.
- b. Any vehicle being used for the purposes of an undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which necessitate the bringing of vehicles into the section of highway to which this order applies.
- c. Traffic associated with the works required within the highway specified above.

	An alternative route will be available for use while the Order is in force being Road From Post Box Cottage To Junction North Of Lodge Cottage, Road From Junction South East Of South Bosent To Turnpike Place, Lodge Hi
