#### 226/17 PUBLIC PARTICIPATION

Young People Cornwall – Catherine Hendy and Kate Sidwell. – A presentation had previously been supplied electronically to Councillors and this was used in Powerpoint form by Catherine Hendy and Kate Sidwell to explain the project and the issue. Other paperwork and leaflets were circulated. They explained that the Youth service provision had been launched in Liskeard in January 2017. It was popular and had been used by 171 young people. There were various strands that offered young people a service focussed on their needs. It was noted that the National Lottery funding for the project would stop in October 2017. An adult steering group was in the process of being formed. One of the immediate first tasks would be to investigate the possibility of grant and other funding to sustain the "Your Way" project beyond October 2017.

Options for support – Two possible options were put forward one would maintain the current provision at a cost of £8,400. The other option would offer a reduced service at £5,250. The Town Council were invited to consider providing support as a bridging exercise and perhaps with ongoing support.

#### Questions and Answers –

- Q What form of monitoring was there of the project?
- A The National Lottery, Cornwall Council and an external assessor monitor the project.
- Q Do other Town Councils give funding supporting to youth projects?
- A Truro, Falmouth, St Austell, St Dennis and Blackwater support youth projects.
- Q What form of operating partnership is there with other Town Councils?
- A This varies, however, having a Town Council representative on the project steering board is common.
- Q What specifically could the Options 1 and Option 2 offer Liskeard?
- A This could vary on the basis of the needs of the young people.

The Mayor thanked them for the presentation. She indicated that, the Council liked the objectives of the project. It would discuss the issue of funding and would require information on some points, such as, costs and outputs.

<u>Ploughman's Festival Committee</u> – Pauline Hubner thanked the Town Council for its financial support for the Festival which had been very well attended with numbers up on the previous year and fantastic feedback. There was concern regarding

- The length of time the wall had been damaged.
- The broken boundary fencing.
- Broken glass before the event from frequent use of the site by drinkers.
- The enclosed nature of the Gardens created opportunities for vandals.
- The current shared vehicle access limited the ability for larger vehicles to deliver to the site.

The Ploughman's Festival Committee members felt that the issues raised above would be improved by the management agreement being progressed, so that the Town Council became responsible for the management of Westbourne Gardens and then carried out the proposed access arrangements.

The Mayor thanked the Committee members for their views. The Town Clerk noted that under the agreement Cornwall Council would retain responsibility for the boundary walls. He also noted that the damage to both the boundary wall and fencing was first reported to Cornwall Council on 2<sup>nd</sup> March 2016. There have been periodic reminders of the needs for repairs such as in advance of the Ploughman's Festival. Cornwall Council had indicated that the item was the subject of an insurance claim.

The Town Clerk noted that on the 18<sup>th</sup> August 2017 Cornwall Council had indicated that a proposed access route for Westbourne Gardens had been reserved across the vacant Dean Denver site.

### 243/17 RESOLUTION OF DECISIONS MADE IN PART II

### YOUNG PEOPLE CORNWALL "YOUR WAY" PROJECT

That the Council notes the urgency of the request due to the ending of National Lottery core funding in October 2017. It notes that the project is attempting to secure funding from other sources into the future.

The Council accepts the principle of supporting the continuation of Youth provision in Liskeard. To assist the Council further, in considering the level and duration of Council funding, the project is requested to submit by 12<sup>th</sup> September 2017, a written request for funding support. This should include:

- 1. What precise service provision and outputs will be funded by the Council. (to include number of themes and activities covered etc, as well as numbers of staff and evenings available. This to include costings.)
- 2. What degree of likelihood is there, that additional match funding sources will be secured. Thereby reducing the ongoing cost of provision to the local precept payer (comparison with how such provision is funded in other towns would be helpful).
- 3. What does the project consider are the most important elements within the range of services that are offered that need to be retained for youth provision viability and why. What would be the impact if no funding were forthcoming from the Council.

The Town Council would seek to have a Councillor upon the project group. This would be the Deputy Mayor, Councillor Tyler Bennetts.

Should the "Your Way" youth provision project require an ongoing Town Council financial contribution beyond April 2018 this would need to be made clear and adequate details provided to the Town Council to assist in budget and precept setting in November 2017.
