Section 14(1) of the Road Traffic Regulation Act 1984 (RTRA 1984)

Temporary Prohibition of Traffic Order 2017

1. The Cornwall Council makes this Order in exercise of its powers under section 14(1) of the RTRA 1984 over an area of highway being Road From Culverland Road To The A390 Between Merrymeet Farm And Callington Road Liskeard between its junction with Granite Way and grid reference SX 25602:65491 as highlighted in red on the plan attached to this Order.
2. The Order shall come into operation on 15th January 2018 and continue until the 19th January 2018 24 hours. The restrictions imposed by this order shall remain in force on such days and during such times as the appropriate traffic signs are displayed. In this order "traffic sign" means a sign of any size, colour and type described or authorised under or having effect as though prescribed or authorised under section 64 of The Road Traffic Regulation Act 1984.
3. The Council is satisfied that the order is needed because works are being executed on or near the road to lay and connect a water main.
4. While the Order is in operation traffic, including bicycle movement, along the highway specified in paragraph 1, will be temporarily restricted. No personnel, except upon the direction of a police constable in uniform, cause or permit any vehicle or pedal cycle to enter on, proceed or wait in the length of road described above.

Nothing in the Order will apply to:

- a. Any police, fire brigade ambulance or coastguard vehicle, or any personnel on official duty, or any vehicle or person authorised by and with the permission of Cornwall Council
 - b. Any vehicle being used for the purposes of an undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which necessitate the bringing of vehicles into the section of road to which this order applies
 - c. Anything done with the permission of or at the discretion of a police officer
 - d. Traffic associated with the works required within the highway specified in Paragraph 1
 - e. Pedestrian access will be maintained
5. An alternative route will be available for use while the Order is in force being Road From Culverland Road To The A390 Between Merrymeet Farm And Callington Road, A390 Between Callington Road And South West Of Hill Farm, Callington Road, St Cleer Road, Tregay Lane, Road From Culverland Road To The A390 Between Merrymeet Farm And Callington Road as highlighted blue on the plan(s) attached to this Order
